So, what is the difference?

Instructional Technology

Technology used to support curriculum, instruction and assessment. Providing current technology tools, such as Chromebooks, help teachers to engage students, differentiate learning and maximize student learning.

Assistive Technology

Federal Definition: "Any item, piece of equipment, or product system, whether acquired commercially off the shelf, modified, or customized, that is used to increase, maintain, or improve the functional capabilities of a child with a disability."

What does the law say about Assistive Technology?

As part of the IEP process, IDEA mandates that the Assistive Technology (AT) needs of students be considered.

What does it mean to consider AT in the IEP process?

Consideration of AT is a brief process conducted within the IEP team meeting.

The IEP team needs to ask, "Does the student need AT to meaningfully participate and progress in the general curriculum?" (OCALI, 2017)

AT Questions to be answered may include:

What is the student expected to do that he/she is unable to do because of his/her disability related need?

Would AT be able to help with that?



Examples of How to Document AT in the IEP




